

TVOKids Story Starter Contest Rules & Regulations

Commencing Thursday January 31, 2019 at approximately 3:30pm (ET) and ending on Friday February 8, 2019 at 11:59 pm (ET) (the "Contest Period") entrants may enter the Story Starter Contest (the "Contest") online at: www.tvokids.com/contests or by mail. No purchase necessary.

The odds of winning are dependent on the total number of eligible entries received.

At the end of the Contest Period, all valid entries that have been received will be entered into a random draw to win the Book of the Month Book Pack (the "Grand Prize"). Any winner of any Prize shall be hereinafter referred to as a "Prizewinner".

TVOKids shall contact the parent/guardian of the selected entrant by phone at the number provided by the entrant.

If TVOKids selects an entrant to win the Grand Prize, and if TVOKids cannot contact that entrant by phone within seven (7) days of selection or the entrant does not otherwise comply with these Contest Rules and Regulations, the entrant forfeits the Prize and TVOKids shall select an alternate entry.

If a Prizewinner's name has already been drawn once, any subsequent selection of that Prizewinner shall be deemed void.

How to Enter:

There are two (2) ways to enter the Contest:

- 1) **Online:** Visit www.tvokids.com during the Contest Period. Fill in the story starter and complete the online entry form by filling in your name, age, and the phone number of your parent or legal guardian so we can contact them if your entry is selected.
- 2) **Mail in Entry:** Write a story about the monsters and write your name, your age, and the phone number of your parent or legal guardian so that we can contact them if your entry is selected, and mail your entry to:

To qualify, all entries must be received on or before 11:59 pm (ET) on Friday February 8, 2019.

All entries and submissions will not be returned and are property of TVO upon receipt.

CONTEST CLOSING: The Contest closes at 11:59 pm (ET) on Friday February 8, 2019.

Eligibility:

The Contest is open to children (i.e. under the age of 16 years of age) who are residents of Ontario, except the Contest is closed employees, volunteers, representatives or agents of TVO and prizing partners and their immediate family members.

An entrant under the age of 13 must have the consent of his/her parent/guardian to submit their personal information to enter the Contest. Without such parent/guardian consent, the entrant cannot enter the Contest.

The parent/guardian of each entrant selected to win a Prize must sign a declaration of compliance with the contest rules and regulations and a release (as attached) in order to receive the prize components on the Prizewinner's behalf.
